Deb Foster's *Glimpse of Heaven* on Saturday, February 5th.

Former San Diegan Deb Foster returns to our group as a speaker on Saturday, February 5th, from 1:30 to 4:00 pm at our usual location, the Harbor Room of the San Diego County Health Services Center. Deb had a fascinating NDE that occurred on December 11, 2002 when she gave birth to her daughter and suffered an amniotic fluid embolus. She was clinically dead for over four minutes while the hospital team tried to revive her.

Deb's story is quite profound. She will relay her experience on the staircase in what she describes as a "glimpse of heaven" and include "the Light of God" and animals that she met on the staircase. Deb will also relay how she came to understand the experience was a true miracle after the message she received in I.C.U. Deb's story has been featured on two San Diego news stations and the May 2005 issue of the *San Diego Union Tribune* article with Beverly Brodsky and the late Claire Schlessinger. She was also one of the people interviewed in the Near-Death segment on ABC's December 2006 and 2007's Barbara Walters special entitled: *Heaven, Where is It? How Do We Get There?* Deb was also interviewed in the December 2005 issue of *Guideposts* about her NDE. She was also featured in the film: *Reflections: Beyond and Back* in 2008. Please come and hear her story and share your own. Bring a friend, especially any animal lovers who wonder where their pets go when they leave this world.

Deb's wonderful story, which still brings tears to my eyes, was shown on the pilot series for *I Survived: Beyond and Back*, now a six-episode series on the Biography channel, along with our former guest Michaela Roesner, describing her veridical experience, and Steve Damroth's fraternal murder. The Biography channel received such good feedback on the pilot that they continued the show, so many others can tell their important and valuable stories to the public.

Directions to Health Services Complex:

3851 Rosecrans Street, San Diego, CA 92110

From Hwy 8 or Hwy 5.

-- Take ROSECRANS exit.

-- Get in left lane and go about 3 blocks.

(Note: When you exit the freeway you're actually

heading toward ROSECRANS on CAMINO DEL RIO WEST!

Rosecrans runs parallel to Camino Del Rio West.)

- Turn LEFT on KURTZ just before reaching SPORTS ARENA.
- Get in left lane on Kurtz and go 2 VERY short blocks.
- Turn LEFT on ROSECRANS and get in right lane.
- Turn RIGHT into the COUNTY HEALTH SERVICES COMPLEX.
- The driveway aims you at our meeting room building in the Harbor Room.

Directions to restaurant after meeting:

From: 3851 Rosecrans St, San Diego, CA 92110 to Souplantation

To: 3960 West Point Loma Boulevard, San Diego, CA 92110-5643 - (619) 222-7404

Head **southwest** on **Rosecrans St** toward **Hancock St**

Continue onto **Sports Arena Blvd** go 0.9 mi

About 2 mins total 1.0 mi

Slight left to stay on Sports Arena Blvd go 358 ft

And go straight total 1.1 mi

Continue onto **W Point Loma Blvd** go 0.1 mi

Destination will be on the **right** by the CVS total 1.2 mi
